Interim General Manager Megan Lucas reported on state and local grant funding currently in progress. Prop 64 Funding and possible County grants offered and supported by Supervisor David Couch. Projects currently in progress or awaiting funding: major changes to the outdoor Basketball courts; lights on the tennis/outdoor soccer courts; lining for pickleball; security locks on the north bathroom; security improvements; babe ruth field rehabilitation to allow for more diversified use; resealing parking lot asphalt and stripping. In addition, Annual Sponsorships, solar energy, and lighting upgrades are being considered. Heidi Witcher of the Buttonwillow School District shared information regarding grant funding received to meet the extended day and hours required by the State. In addition to adding special programs by the school, partnerships with the Recreation District and Buttonwillow Branch of the Kern County Library will provide additional opportunities to meet the needs of the students.
